This memorandum is in regard to the Tunica 2008 Mississippi Policy Conference (“Conference”) being held by the Congressional Black Caucus Political Education and Leadership Institute (“Institute”) August 14-17, 2008 . The Institute is grateful for your interest and/or financial support of the Conference. With regard to the scheduled Conference activities (“the Conference Events”), the Institute confirms the following:

1. The Institute is a nonprofit organization whose program activities include policy conferences, policy research and education, and political leadership training all of which, are conducted in a nonpartisan manner. The Institute is governed by an independent board of directors and is recognized by the Internal Revenue Service as a “social welfare organization” (as defined by Section 501(c)(4) of the Internal Revenue Code). The Institute is autonomous from, and completely unrelated to, the National Democratic Party, the National Republican Party, either of the presidential candidate campaigns, or any political committee or partisan political organization.
2. The Institute Conference Events are part of our organization’s ongoing program activities and are wholly and completely separate from the activities of any national political party or any other party committee or candidate campaign committee. Further, no political fundraising of any kind will be held or take place at a Conference Event.
3. No part of any financial contribution to the Institute in support of its programs (including the Conference Events) have been, are being, or will be used to: (a) make a political contribution in support of any candidate for public office, (b) make any expenditure that will advocate the election or defeat of any political candidate (c) make any electioneering communication(s), or (d) make any direct communication with a covered executive branch official in an attempt to influence the official actions or positions of such official.
4. The Institute neither employs nor retains a registered lobbyist.

5. The Institute extended an invitation to Members of the House of Representatives and congressional staff to attend and to participate in the Conference Events and made the requisite filings with the House Committee on Standards of Official Conduct. Further, the Conference Events have been planned and organized in a manner that we believe to be in full compliance with the ethics and gift rules of the House of Representatives and the most recent relevant guidance that has been issued by the House ethics panel. Specifically:

- The Conference Events have not been organized for the purpose of “honoring” a Member of Congress or a congressional staff member. The participation of Members of Congress (or congressional staff) will be limited to activities as permitted under guidance of the House ethics panel. For example, the Institute believes that the Conference policy luncheons, workshops and other events meet the requirements of “widely attended events”, as defined by guidance of the House ethics panel. For example, the Institute fully expects that (a) more than 25 non-congressional attendees will participate in these Conference Events, (b) attendees will reflect the participation of a broad range of industries, firms, organizations, professions and of persons with diverse political philosophies or ideologies; and (c) the participation of a Member of Congress and/or congressional staff is reasonably related to the performance of his or her respective official duties. Members of Congress or congressional staff will charge the fair market value for receipt of an item or participation in an activity the Institute reasonably believes that, without such payment, would violate Congressional ethics rules.
- For all Conference Events, the Institute has contracted to rent and use the event space at the fair market value price charged to others and has not received any discount or otherwise received preferential treatment by the owner of the space.

The above information was reviewed and developed with the assistance of the Institute’s legal counsel. The information is advisory in nature only and is not, nor intended to be, a legal opinion of the Institute or its counsel. The Institute is happy to provide factual information with respect to the Conference Events, however, you may wish to seek independent counsel if you have legal questions. Again, please accept the Institute’s sincere appreciation and thanks for your or your organization’s interest in, or support of, its activities and programs.
