**Russia To Debate Yeltsin Impeachment**

MOSCOW (AP) – Russian President Boris Yeltsin's foes in parliament today reiterated their intention to support an impeachment vote expected this week. The leaders of Russia's Communist Party, which has led the bid to impeach Yeltsin, met to discuss tactics for the impeachment debate scheduled to begin Thursday in the lower house of parliament, the State Duma. Yeltsin's rivals have been trying for years to remove him from office, and the current impeachment charges are the strongest yet. Still, the motion has little chance of success because even if the Duma approves it, Yeltsin cannot be ousted unless it also is passed by the upper house of parliament and the Supreme and Constitutional Courts.

**U.S. Says Serb Pullback Not Enough**

BELGRADE, Yugoslavia (AP) – Yugoslavia announced a partial withdrawal of its forces from Kosovo today, but President Clinton and NATO said it wasn't enough to stop allied bombing. The announcement, apparently aimed at maintaining momentum toward a peace deal, gave no indication of how many troops have been withdrawn or how many were left. Meanwhile, NATO carried out daylight bombings on several towns in central and western Serbia, killing four civilians and smashing a factory in one 20-minute bombardment, Yugoslav media reported.

**China Breaks Military Ties With US**

BEIJING (AP) -- China broke off military ties and various other contacts with the United States today. Chinese officials also demanded those responsible for NATO's bombing of its embassy in Yugoslavia be "severely" punished. China's suspension of high-level military ties – and talks over arms control, international security and human rights – signaled one of the lowest ebbs for China-U.S. relations in 20 years. Meanwhile, thousands protested at the U.S. Embassy in Beijing for a third day.

#### **More Protests In China Feared**

BEIJING (AP) – Protests against NATO's accidental bombing of the Chinese Embassy in Yugoslavia ebbed Tuesday, but the U.S. ambassador warned that the return to Beijing of the remains of three Chinese killed in the attack could touch off more unrest. A special plane bearing the ashes of the three journalists was due in the capital Wednesday morning. A planned live television broadcast of the arrival was expected to heighten emotions over the bombing.

#### **NATO Doubts Kosovo Troop Pullout**

BELGRADE, Yugoslavia (AP) – NATO says it does not believe Yugoslav President Slobodan Milosevic has begun withdrawing his forces from Kosovo. White House spokesman Joe Lockhart said "you can probably put this in the category of another long list of promises that Milosevic has made that he hasn't kept." Five people were reported killed as allied attacks continued today. NATO said there was no evidence that Milosevic has withdrawn any of the estimated 40,000 troops and special police he has deployed in the Serbian province since he launched a crackdown in February.

#### **U.S. Doesn't Expect China Opposition**

WASHINGTON (AP) – Defense Secretary William Cohen said today the Clinton administration did not think China would block a diplomatic solution to the conflict in Yugoslavia. Cohen told a Senate Appropriations subcommittee hearing that China should accept President Clinton's apologies in the accidental bombing of their embassy in Belgrade. Chinese President Jiang Zemin had not yet responded to a request by Clinton to talk by phone.

Bernie,

How are you, Hala, Celine and Joe? I trust all is well.

I have a copy of your response to David. I would never drag you into anything, actually quite the contrary.

I am sorry that I have to burden you with any of this at all. But I need you and my family needs you. I have done my best to keep you out of it all along, as I am told to my own peril. But as a friend I was mindful of the sensitivity of your position. This has been a difficult and lonely time and I miss you very much. Now I need you as a friend to do nothing more than be willing to state the truth as to the things you do know.

1. Bern, when you first introduced me to Gary, one of the concerns you had was that i never get exposed, hurt or put in a position to testify. Gary said to you that i would never be put in a position to testify, where a wire or be exposed to prosecution on information furnished and developed by me. You said you have been doing this a long time and if the bad guys found out I was working with the bureau they would try to blame me. You were right!

2. The reason you introduced me to the bureau started with the threats made against me by garafolo, whom I had never even met at this point.

The ausa that had started this case has not been involved since a year ago. Out of the 19 defendants, people whom I don't know nor have met, 17 plead out. I was told by my former council he has never seen people get deals that good. I was supposed to have a hearing last spring that I am told would have resulted in a dismissal, but you would have had to testify in open court. I did not want to get you involved in that at that time. Now that there is know one left, other than myself and one other whom I don't know, never met and is not in the same count as I am, the ausa is not interested in trying this case against me. After a status conference last wed. the ausa spoke with an attorney who has not signed on as my attorney yet and myself. He said the only thing they have is 2 or 3 people they made deals with who will testify that I said I had to pay someone inside Willis coron. He also acknowledged that no one was ever paid in Willis. He said he would like to try to get rid of this case. But that would require me to plea, and I will not plea as I am innocent. He also said that originally all they wanted was for me to testify, but that is not how the agent presented it to me in 99, and that what I said in 96 to Gary was different from what I said when interviewed in 99 by Leo. There is a good reason for that because what I said to Gary in 96 was information I had gotten completely from Steve blanco and not anything I knew first hand and Gary knew that but had never made the distinction in his inserts. What I was asked in 99 was what I knew firsthand about u.s. bridge and of course it was different from what I had developed at Gary's request. The ausa does not know anything about the points I have asked you in this letter at this time or that I am even thinking about you. I don't have counsel at this time and the attorney I am speaking with will only take this if you are willing to tell him you remember those points because there is little time. If not I am representing myself at trial DEC 3. Wish me luck. I may need to call you as witness at that time. There is a status conference Friday 16 Nov. and the attorney has to enter his appearance or not at that time. So as u can see I would need you to speak to him by tomorrow. I do have an investigator at least, his name is Bob Debellis, he retired from the bureau less than 2 yrs. ago after 34 yrs. The attorney believes this will end without trial with your calling him. Please be there for me.

I often hold Ava and I think of Celine. Isn't it the best. I really miss and love you guys so much.
