

**ARTICLES OF INCORPORATION
OF
Our Children, Inc.**

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of the corporation under the NON-PROFIT CORPORATION ACT (D.C. Code, 1981 edition, Title 29, Chapter 5), adopt the following Articles of Incorporation:

FIRST: The name of the Corporation is Our Children, Inc.

SECOND: The period of duration is perpetual.

THIRD: The purposes for which the corporation is organized are:

A. To provide spiritual guidance and instruction, so as to deter crime and violence and promote positive community and social relations through proclaiming the gospel of the Lord Jesus Christ to the citizens of the District of Columbia and adjoining cities, states and counties.

B. To imbue a sense of respect for self, for others, and for all cultures, by exposing participants to various spiritual social and cultural experiences.

C. To provide information and education regarding drug and alcohol abuse, and other health matters.

D. To help the children become self-sufficient by encouraging continued education and helping them to become marketable to potential employers.

FOURTH: The Corporation shall have members.

FIFTH: The Corporation shall be divided into two classes of voting members designated as General Members and Associate Members. The qualification of such members shall be provided in the by-laws.

SIXTH: The internal affairs of this corporation shall be managed by its Board of Directors who must be residents of the Metropolitan Area or members of the Corporation, and each director shall be elected for the term of one year. The manner of or such election and such directors shall be provided in the by-laws.

SEVENTH: Provisions for the regulation of the internal affairs of the Corporation including the distribution of assets on dissolution and/or final liquidation shall be stated in the by-laws.


