# **Role of Government Survey**

## Methodology

The Washington Post/Kaiser Family Foundation/Harvard University Survey Project is a three-way partnership and an experiment in combining survey research and reporting to better inform the public. The Role of Government Survey, the 20th in this partnership series, was conducted by telephone from September 22 - October 3, 2010 among a nationally representative random sample of 2,054 adults ages 18 and older. Telephone interviews conducted by landline (1,383) and cell phone (671, including 289 who had no landline telephone) were carried out in English and Spanish by Social Science Research Solutions (SSRS). The margin of sampling error for results based on the total sample is plus or minus 2.5 percentage points.

Representatives of The Washington Post, the Henry J. Kaiser Family Foundation, and Harvard University worked together to develop the survey questionnaire and analyze the results. Each organization bears the sole responsibility for the work that appears under its name.

The project team included Jon Cohen, The Washington Post director of polling and Kyle Dropp, assistant polling analyst; Drew E. Altman, president and CEO of the Kaiser Family Foundation, Mollyann Brodie, senior vice president for executive operations and director of public opinion and survey research, Elizabeth Hamel, associate director of public opinion and survey research, and Carolina Gutierrez, survey analyst; and Robert J. Blendon, professor of health policy and political analysis at the Harvard School of Public Health and the John F. Kennedy School of Government, and John M. Benson, managing director of the Harvard Opinion Research Program in the Harvard School of Public Health. Consultants Jack Citrin and Meredith Chaiken also contributed.

Please note: (1) Table percentages may not add to 100% due to rounding. (2) Values less than 0.5% are indicated by an asterisk (\*). (3) "Vol." indicates that a response was volunteered by the respondent and not an explicitly offered choice. (4) Sampling error is only one of many potential sources of error in this or any other public opinion poll.

Trends in this document all come from national random sample surveys with interviews of at least 1,000 adults. Most have a margin of sampling error of plus or minus 3 percentage points. "RV" indicates that a trend question is based on registered voters; "LV" indicates it is based on likely voters. Trend data from prior surveys refers to polls by The Washington Post or the Kaiser Family Foundation and other partners, unless otherwise noted.

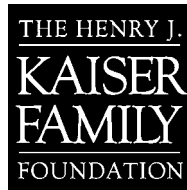
